INFORMATION RELEASE TO SUBCONTRACTORS

We advise that on 23 May 2016, the directors of the company appointed us as Joint and Several Administrators pursuant to Section 436A of the Corporations Act 2001 (“the Act”).

We note the company ceased to trade upon our appointment and we are required to take control of the assets of the company. We are also currently assessing the financial position of the company and acknowledge and understand that the placement of the company into Voluntary Administration has caused inconvenience to you. As mentioned, we are also endeavouring to urgently take control of and deal with the business assets of the company.

If you presently have in your possession any assets or property belonging to the company, then you must contact our office urgently in order that arrangements can be made for those assets and belongings to be collected by us or delivered to our agent. We are required to convene a first meeting of creditors within 8 business days following our appointment and in that regard, a notice of the meeting and other relevant meeting documents will be sent to you over the coming days.

The effect of our appointment is to place a moratorium on the payment of unsecured creditors' accounts in relation to trading and other debts incurred up to the date of our appointment (i.e. 23 May 2016), until creditors make a decision about the company's future. That decision will be made at a second meeting of creditors, to be held within 25/30 business days following our appointment. Creditors will receive notice of that meeting in due course.
